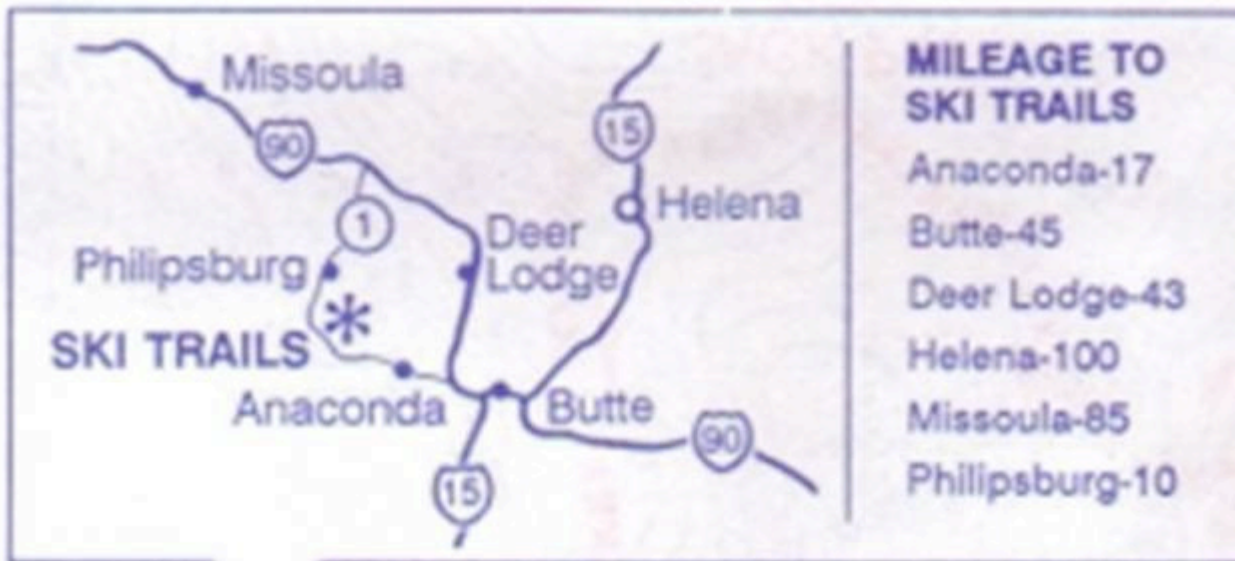

Rumsey Trail 301	4.0 km. (2.5 mi.)
Jack Pine Trail 302	5.6 km. (3.5 mi.)
Echo Lake Trail 303	3.2 km. (2.0 mi.)
Cable Loop Trail 304	1.5 km. (0.9 mi.)
Powerline Trail 305	0.6 km. (0.4 mi.)
Cabin Trail 306	2.7 km. (1.7 mi.)
Discovery Trail 307	1.3 km. (0.8 mi.)
Cable Campground Trail 309	3.7 km. (2.3 mi.)
Lodgepole Ridge Trail 310	6.1 km. (3.8 mi.)
Campground Trail 312	1.0 km. (0.6 mi.)

CROSS-COUNTRY SKI TIPS

- * Have at least three people in your party.
- * Do not underestimate the time required. [snow and fallen trees can slow your progress fraction of a mile an hour.
- * Take a map and compass if you are not familiar with the terrain. Carry a spare ski tip; a car cigarette lighter or matches to make a fire; a flashlight and a whistle to attract attention if you are injured or hurt; and a suitable pack for your trip.
- * Check your map for the proper route. Use a checklist to be sure you have all necessary equipment.
- * Check your equipment before you start. Tighten screws, adjust bindings and inspect cables.
- * Choose your companions carefully. Their ability will determine the extent of your tour.
- * Set the pace to suit the least able skier.
- * Leave your trip schedule with a responsible person, and report your return.
- * Keep warm with wool clothing and light windbreaker. Use layers of clothing. avoid perspiration.
